MEMORANDUM FOR MR. PLUMMER

SUBJECT: Executive Order 11905--Restrictions on
Electronic Surveillance

Request that the memorandum on the right to
General Kulpa be signed.

The Staff is in the process of formulating a package
for you to forward to the OSD General Counsel, who has been
designated as the DOD implementing authority for the
Executive Order. The package will:

- a. Define our domestic requirements vis-a-vis the
Executive Order;
- b. Request a waiver of the Executive Order on the
basis of the nature of our requirements;
- c. Outline and request approval of the NRP proce-
dures, as required by the Executive Order, for conducting
and managing domestic surveillance requirements.

In preparing this package, the Staff will be working
closely with personnel from each Program Office, the Air
Force General Counsel through Major [redacted] and with the
IC Staff. In addition to the package for you to forward to
Mr. Wiley, the OSD General Counsel, we will have available
a specific breakout of each of our recurring photo and
SIGINT domestic requirements. We anticipate having the
package within the next two weeks.
