<u>Issue:</u> What should be the level and extent of OSD participation in the activity of the NRP Executive Committee?

Policy:

An NRP Executive Committee, consisting of the Deputy Secretary of Defense, the Director of Central Intelligence, and the Special Assistant to the President for Science and Technology, is hereby established to guide and participate in the formulation of the NRP through the DNRO. (The DNRO will sit with the Executive Committee but will not be a voting member.) If the Executive Committee can not agree on an issue the Secretary of Defense will be requested to sit with the Committee in discussing this issue and will arrive at a decision....

The Executive Committee shall meet on the call of either the Deputy Secretary of Defense or the Director of Central Intelligence. All meetings will be attended by the DNRO and such staff advisors as the Deputy Secretary of Defense or the Director of Central Intelligence consider desirable.

(From August 11, 1965 DOD/CIA Agreement for Reorganization of the NRP)

 - a. restricted pre-briefing sessions;
- b. actual attendance as advisors at formal meetings of ExCom.

ExCom meetings by representatives of these elements should probably be limited to the principals, i.e. the DDR&E and the ASD (Comptroller). The staffing of agenda items could most effectively be accomplished in a pre-briefing for these principal representatives; as could any additional staffing required for particular agenda items by other elements of the OSD.

Attendance at formal pre-briefing sessions for the DepSecDef and ExCom meetings should probably be restricted to the DNRO, his Comptroller and Staff Director, the DDR&E and the ASD (Comptroller).

Attendance of all others should be limited to those individuals actually participating (briefings, presentations, etc) on ExCom agenda items and then only for those specifically designated agenda items.

Debriefings of ExCom activity and decisions could be accomplished through controlled dissemination of the minutes and further discussions among the principal (attending) representatives and their staff elements.
