

Satellite Systems

1. DISCOVERER Vehicle Acceptance #1058: (SECRET)

DIECOVERER Vehicle No. 17 was accepted by the Air Force Acceptance Team on 6 January 60. It is noted that this vehicle is the last of the single tank, Thor boosted, vehicles. Follow-on DIECOVERER will contain dual tankage.

2. Solar Cell Manufacturing: (SECRET)

Members of WEZN and IEZJR, in conjunction with AMC Aeronautical Systems Center personnel, recently completed a survey of solar cell requirements in support of the Satellite Systems programs. Total requirements for the next two/period were estimated to be 1.4 million solar cells plus an approximated 15% spares requirements. It was evident, after coordination with the two suppliers, Hoffman Semi-Conductor and International Rectifier, that the combined manufacturing capability of these two companies far exceeded the existing requirement. Since the Satellite Systems programs appear to represent the majority of the total Air Force requirement, it has been decided to investigate this problem in further detail. The object of this investigation will be to insure retention of future manufacturing capability for solar cells. The importance of this investigation is supported by the anticipated increased quantities of solar cells required for follow-on satellite activity.

3. Overtime Utilization on Satellite Systems Programs: (UNCL)

The rate of overtime utilized by Lockheed Missiles and Space Division on satellite systems programs for November 1959 was 7.0% as compared to 7.7% for October.

4. AFRMD Program Presentations: (COMF)

Hq USAF TWX AFDAT 61415 dated 8 January 60 to BMD established the following tentative schedule for presenting the SAMOS/MIDAS Development Program:




