SUBJECT: MOL History

Your approval is requested for the preparation of a documented history of the MOL Program.

A detailed history and chronology of actions related to MOL could provide an invaluable source for statements and other materials for DOD, Congress and other agencies. A comprehensive identification of documents on MOL, both internal and external to the MOL Program Office, would serve as a helpful checklist for management purposes. A narrative account of the approach and rationale associated with MOL planning, approval and implementation would certainly be of benefit as we chart our future course.

To be of value, a MOL history should be in considerable detail, but must be conveniently organized. It should present clearly and factually the picture of Air Force planning, policies, proposals, and funding. Both the documented narrative history and the chronology should go back to the early beginnings of MOL and carry the story forward to the present time. The coverage would of necessity continue as the program progresses.

This procedure has been used to advantage by the Office of Space Systems (SAF-SP). That office has found it appropriate to use the full measure of classified security information. We would expect to do the same.

With your approval, I propose that the USAF Historical Division Liaison Office (AFCHO) be assigned responsibility for preparing the MOL history. AFCHO, attached to Headquarters USAF, has inthe past prepared a number of top-level historical narratives on various aspects of the Air Force space program.

Your approval of this project is requested; any suggestions or guidance you may have would be appreciated.
