- 1. Pursuant to the discussion held 14 January 1965 between yourself, Dr. McMillan and General Ferguson, it was agreed that General J. Maxwell should continue to chair the SSB for the purpose of selecting three contractors for the initial study of the reoriented MOL program.
- 2. Acting for and in the absence of General Maxwell, I have submitted under separate cover the complete list of contractors considered by the working panel of the SSB, together with the criteria and the list of contractors determined to be qualified.
- 3. It was determined that in order to meet the dates imposed by the 4 January DDR&E Directive on the reoriented MOL program, extraordinary procedures would be required to complete the selection and approval process. Furthermore, that for the initial selection of study contractors all board members should have special clearances.
- 4. Therefore, the following names are submitted for your approval to undertake the initial task of selecting three contractors to proceed with a 60-day study effort on the reoriented MOL program:

SUBJECT: Qualified Contractors

TO: General Schriever

A DDR&E memo of 6 January 1965 to the Under Secretary of the Air Force defined the objectives of the MOL program.

An 8 January 1965 implementation directive to SSD (SSH) contained the following:

- a. Fund three preliminary design studies of MOL configurations employing Titan IIIC and Gemini B.
 - b. Lab configurations should include provisions for:
- (1) Testing concepts of assembly of large optical devices in space.
 - (2) Servicing large optical systems.
- (3) Testing concepts of assembly and service of large radio telescopes in space.
 - (4) Testing high resolution surveillance radar concepts.
 - (5) Manned experimentation facilities.
- c. The three contractors chosen must be qualified to <u>build</u> the laboratory module whether the final approach selected is:
 - (1) Titan IIIC and Gemini B and lab module; or,
- (2) Saturn IB and Apollo CSM and lab module (in place of LEM Adaptor Section).
- d. Study work will be fully funded and final contractor will be one of three selected without further competition from industry.

Contractor must be selected, approved and given go-ahead by 1 March 1965 in order to meet the schedule for completion and analysis by mid-May.

Further guidance was issued 14 January 1965. In response to your verbal request the attached list of contractors determined to be qualified is submitted for your approval.

These contractors have been determined to be fully qualified based on specific criteria specified in paragraph 25 of AFM 70-10 and certain other specific factors adopted by the MOL SSB.

The specific criteria and the determining factors are inclosed as a matter of record together with a list of forty-nine other contractors determined as not meeting the criteria.

Request you approve the list of twenty qualified contractors recommended to receive the RFP's when authority to proceed has been issued.
