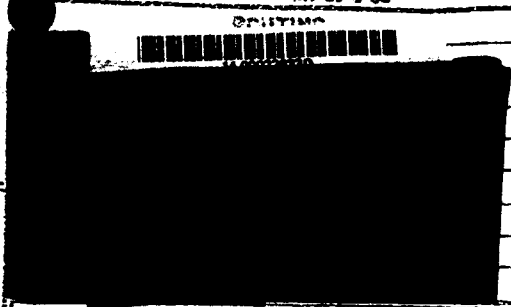

AGREES TO COOPERATE WITH THE [REDACTED] BY RESPONDING TO INVITATIONS TO MEETINGS, REQUEST FOR TECHNICAL INFORMATION, AND REQUESTS FOR RESEARCH AND DEVELOPMENT PLANNING DATA ON ALL MATTERS PERTAINING TO THIS CONTRACT AND BY DISCUSSING WITH THE [REDACTED] EMPLOYEES, TECHNICAL MATTERS RELATING TO THIS PROGRAM. THE CONTRACTOR FURTHER AGREES TO ACCEPT TECHNICAL DIRECTION AS DESCRIBED HEREIN.

C. FORMALIZATION OF GENERAL SYSTEMS ENGINEERING AND TECHNICAL DIRECTION GENERATED BY THE [REDACTED] OF EFFORT UNDER THIS CONTRACT WILL BE DOCUMENTED BY THE ISSUANCE OF A SERIALLY NUMBERED "TECHNICAL DIRECTIVE", ISSUED BY THE [REDACTED] AND SIGNED BY THE APPROPRIATE GOVERNMENT CONTRACTING OFFICER, STATING THAT COMPLIANCE WITH SUCH "TECHNICAL DIRECTIVE" IS DIRECTED PURSUANT TO THE CLAUSE OF THIS CONTRACT ENTITLED "CHANGES".

2. REVIEW ALL CONTRACTS AND MAKE CHANGES TO ELIMINATE REFERENCE TO LMSC SE/TD AND SUBSTITUTE WHERE APPROPRIATE THE WORDS "INTEGRATING CONTRACTOR".

3. DELETE ALL REFERENCE TO SSD AND REPLACE WITH [REDACTED]

4. REQUEST THE ABOVE CHANGES BE IMPLEMENTED IN REFERENCED CONTRACTS AND WE BE NOTIFIED WHEN ACTION IS COMPLETED. [REDACTED]
