MEMORANDUM FOR THE UNDER SECRETARY OF THE AIR FORCE

SUBJECT: DOD Representation on the U.S. Delegation to the  
UN Outer Space Committee Meeting

You are requested to furnish an Air Force officer thoroughly familiar with Defense space programs to act as DOD adviser to the U.S. delegation to the meeting of the Legal Subcommittee of the UN Committee on Peaceful Uses of Outer Space. This meeting is to be held at UN Headquarters, New York City, approximately 20 September to 4 October 1965. The Legal Subcommittee has been charged with preparation of two agreements: Assistance to and Return of Astronauts and Space Vehicles and Liability for Damage Caused by the Launching of Objects into Outer Space.

The officer selected should report to Colonel Marshall E. Sanders, Room 4D824, the Pentagon, on the morning of 17 September 1965 for briefing prior to proceeding to New York. Colonel F. Ned Hand has ably represented the DOD at previous meetings of the Legal Subcommittee, at which the above mentioned agreements were discussed. The Legal Counsel of the Department of State has requested that Colonel Hand again be made available.

The Office of the Secretary of Defense is prepared to pay the travel and per diem expenses of the officer selected for this duty. A fund citation can be obtained by calling the ISA Executive Office (Lt. Colonel James H. Carroll, Extension 78126).
