Description: What needs to be done?

(U) The IRRG is re-tasking a few NRO components to request further review (a closer look) at the treatments of the FY2013 CBBJ for the following reasons:

- 1. We need to ensure that the Research and Technology and Enterprise Management sections of the CBBJ has been reviewed by all potential stakeholders. Please review, or verify that you have reviewed these two sections of the document. We highly recommend that you also peruse the complete document as some of your equities also reside in other sections and tables throughout.
2. Some initial reviews have the appearance that decisions for denial of entire portions/paragraphs are based on portion-markings, rather than line-by-line review. Redaction recommendations should include only the specific words or phrases within each portion/paragraph that make it sensitive. The law requires release of all segregable non-sensitive information.
3. In many of the tables or funding or position statements, some reviewers have marked them in their entirety for withholding, while others have marked individual items of information within these portions for denial. We need to arrive at a consistent treatment for these items. Please verify that your treatment provides for release of any segregable non-sensitive information.

(U) The IRRG understands that in some cases, denial of entire portions of documents is a correct and valid treatment. We are requesting this additional review to ensure that the treatment that moves ahead for final review completely protects information as required, but also represents a correct and legally-defensible response under the law.

(U) If you wish to uphold the validity of your component's initial treatment, please provide a statement to that effect. If you wish to revisit your initial response, please provide revised treatments as appropriate.
