THIS MESSAGE SETS FORTH PROPOSED SECURITY POLICY FOR THE FROG SYSTEM PRESENTLY DESIGNATED

1. IT IS OUR INTENTION TO CONTINUE USE OF THE DESIGNATOR THROUGH THE PROPOSAL PERIOD AND AT LEAST UNTIL THE INITIATION OF THE SYSTEM ACQUISITION PHASE, BY WHICH TIME SUB CONTRACTORS WILL HAVE BEEN SELECTED AND CONTRACTS NEGOTIATED. WE FEEL THAT THIS ACTION WILL GIVE US THREE ADVANTAGES:

- A. MAINTAIN SECURITY COMPARTMENTATION.
- B. RETAIN A LOW KEY POSTURE THROUGH CONTRACTUAL NEGOTIATIONS.
