MEMORANDUM FOR: ALL SAFSP PERSONNEL

SUBJECT: Executive Order 12333, United States Intelligence Activities, 4 Dec 1981

1. Executive Order (E.O.) 12333 establishes policy guidelines and restrictions for U.S. intelligence activities. DOD supporting documents have also been updated recently to provide specific guidance on reporting requirements and other E.O. 12333 associated procedures and activities. Of particular importance and relevance to NRO activities are procedures 2, 3, 4, 5, 11, 12, 14 and 15 in DOD 5240.1-R, Dec 82.

2. All personnel should be reminded that adherence to E. O. 12333 and associated supporting directives and regulations is required of all NRO activities. To insure compliance with this requirement, the Assistant to the Secretary of Defense for Intelligence Oversight, ATSD(IO), retains direct on-site inspection authority for Programs A and C and is also available as a direct point of privileged (i.e., confidential) contact for reporting, E. O. 12333 violations. The ATSD(IO) phone numbers are Autovon: 225-9542 or KY-3 Pentagon 2351.

3. This avenue of reporting can be used in lieu of or in conjunction with other available Inspector General Offices, such as myself in my SP-2/IG role, in instances requiring direct privileged communications.
