MEMORANDUM FOR INTERDEPARTMENTAL CONTINGENCY PLANNING COMMITTEE (ICPC) DEPUTY DIRECTOR FOR SCIENCE & TECHNOLOGY, CIA

SUBJECT: ICPC Responsibilities, Title, and Membership

Since the transfer of Project IDEALIST U-2 assets to the Strategic Air Command terminated NRO air vehicle operations, I plan to propose to the Deputy Secretary of Defense that the National Reconnaissance Program (NRP) ICPC responsibilities be modified by terminating responsibility for contingency planning and coordinating for air vehicle operations. Additionally, I am proposing that the name of the ICPC be changed to the Satellite Contingency Coordination Group (SCCG), and that the membership be modified by changing the NRO Staff Director from Executive Secretary to a member, changing the CIA member from the Director, Office of Special Activities to the Director, Office of Development and Engineering, changing the Assistant for Security from the Secretariat to an advisor, transferring the Secretariat responsibilities within the NRO Staff, and expanding the Working Group to include a representative of each member and advisor.

Request your coordination on the attached proposed memorandum for the Deputy Secretary of Defense.

Interdepartmental Contingency Planning Committee SUBJECT: (ICPC) Responsibilities, Title and Membership

As Chairman of the Interdepartmental Contingency Planning Committee (ICPC) the Director of the National Reconnaissance Office is responsible for insuring that a fully coordinated U.S. Government response is available in the event of contingencies related to satellite or air vehicle overflight of denied areas. Since transfer of IDEALIST U-2 assets to the Strategic Air Command terminated NRP air operations, request your approval to revise the NRP ICPC organization and responsibilities to reflect this change.

The revision will include a change in the ICPC membership, and the deletion of responsibility for preparing and coordinating air vehicle contingency plans. I believe the air vehicle contingency plans should be the responsibility of the Joint Chiefs of Staff, who now have operational responsibility for air vehicle reconnaissance operations. Contingency plans affected by such a change would be those pertaining to SAC SR-71, U-2, or drone operations over sensitive or denied areas.

Contingency planning responsibilities remaining with the NRP ICPC would be those related to NRP satellite operations, and would include events such as a Soviet coorbital intercept threat, and other undefined contingencies.

In order to more accurately reflect the revised responsibilities, as well as the functional nature of this body, it is proposed that the title be changed to the NRP Satellite Contingency Coordination Group (SCCG).

SUBJECT: National Reconnaissance Program (NRP) Satellite Contingency Plan

REFERENCE: Minutes of ICPC Meeting 14 June 1971 (BYE-12902-71).

Attached, for your guidance, is a copy of the NRP Satellite Contingency Plan.

This plan supersedes that issued under BYE-12982-70. It has been amended and approved by the Deputy Secretary of Defense in accordance with the reference and now includes (a) policy and procedures to follow in the event of a Soviet coorbital intercept threat to one of our maneuverable photographic reconnaissance satellites, and (b) appropriate press releases for use by the Department of State with the concurrence of the Chairman of the ICPC should there be official or unofficial publicity of an attempt by the Soviets to interfere with NRP Satellites.

The Committee members represent their principals and, in turn, insure that their principals and other appropriate U.S. Government officials are appropriately informed of NRP (National Reconnaissance Program) contingency matters. The Committee members also insure that those reconnaissance operations which are not a part of the NRP, but which may cause international incidents adversely affecting the overflight operations of the NRP, are brought to the attention of the ICPC, as necessary.

that contingency plans have been prepared, considered, and approved by the ICPC for all overhead reconnaissance operations. The Secretariat provides for periodic review of all NRP contingency plans so that their adequacy in light of current circumstances can be properly assessed.

The Secretariat prepares agenda and minutes of all meetings of the ICPC, maintains for the Chairman a complete dossier of all correspondence relating to Committee consideration and approval of contingency plans, and performs other items of general Committee business. Additionally, the Secretariat insures that the Chairman, Committee Members, and responsible Program Offices are kept fully informed on matters relating to the business of the Committee.

3. The ICPC Working Group:

In the event of a contingency incident, the ICPC Working Group will closely monitor all events and actions to insure that the contingency plan is adequate to the particular event. If it is not adequate, they will advise the DNRO immediately and recommend appropriate further action.

The Working Group will be responsive to the DNRO in the event of a contingency incident, and, when interdepartmental coordination or cooperation is required, the members will be the ones to take such action.

In the event of a contingency incident, the Working Group will maintain a complete dossier of the matter for the DNRO. Additionally, with the assistance of the ICPC Secretariat, the Working Group will insure that the Chairman, ICPC Members, responsible Program Offices, and other United States Government officials are kept informed regarding contingency incidents.
