3. FURTHER, THE FUNDING OF THE INTEGRATION COSTS (APPROXIMATELY \$110000) AS OUTLINED IN YOUR REFERENCED MESSAGE, WILL BE PROVIDED BY AF/RDS (SPACE TEST PROGRAM). THIS DECISION WAS REACHED BY MUTUAL AGREEMENT WITH GENERAL STELLING AND DR. COOPER ON 26 APRIL 1974. THE PRINCIPAL DMA POINT OF CONTACT FOR THIS EFFORT IS DR. [REDACTED] HQ DMA/PRA. UNQUOTE.

2. REQUEST YOU INDICATE YOUR INTENTIONS WITH REGARD TO THE PALLET PROJECT FOR FY-75 FUNDS IN PARTICULAR, AND PROVIDE A SCHEDULE WHICH INCLUDES ANY PRELIMINARY TECHNICAL MEETINGS WITH DMA AND ASSOCIATED CONTRACTORS.
