SUBJECT : Change to HEXAGON and ZAMAN Program Call, FY70-74

REFERENCE : BYE 8693-68, dated 5 January 1968

1. On 30 January 1968, a meeting was held in OSP to discuss HEXAGON and ZAMAN program changes. The attendees were:

Messrs Donald Patterson, PD/H/OSP James McDonald, C/PAD/OSP SA/PAD Lemite Dirks, C/D&AD/OSP OSA Communications Div. OSA Communications Div.

2. Mr. Patterson advised that the HEXAGON communications program call should be modified by deleting the data and secure voice installations connecting Headquarters and the West Coast concenter from the FY70 call, with the secure voice (only) rescheduled for FY71. The teletype circuitry connecting Headquarters with a 24-hour West Coast concenter and (contractor) is to remain as programmed. In accordance with these changes, the HEXAGON communications equipment, leases, and personnel estimates shown on pages 15, 16, 19, and 20 of the reference document should be changed to reflect the following:

WY70: A 24-hour teletype concenter on the West Coast and a secure voice circuit between Headquarters and \_\_\_\_\_\_ The West Coast concenter coverage and maintenance will require five cryptographers and one technician. The contractor terminal of the secure voice circuit can be handled by contractor furnished personnel.


