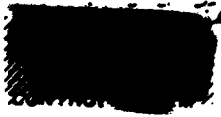

SUBJECT: Briefing to Congressman Mollohan

At Mr. Reed's request, Lt Colonel Alser, Lt Colonel Cromer and I briefed Congressman Mollohan and Mr. Lally, his Investigations Staff Chief on the conduct of the National Reconnaissance Program and the

Mr. [redacted] his Executive, Colonel Johnson, also [redacted] the briefing. Mr. Mollohan seemed extremely interested in the program and appeared to understand the reason for the special handling required of the [redacted]

I believe [redacted] this morning with Mr. Mollohan and Mr. Lally is sufficiently high that if embarrassing questions are asked by the Special Subcommittee on Defense Communications, that Mr. Reed or another knowledgeable testifier will have the ability to offer a response privately and not be called to task.

Following the briefing, I informed General Edge of its outcome and also General Maglione in order to keep him apprised of our contact with the House Armed Services Committee. We have offered to be of any further assistance as required during the course of the hearings.
