## MEMORANDUM FOR RECORD

SUBJECT: Planning Meeting for Intelligence Programs Briefings to the Senate Appropriations Committee


This morning I met with Mr. Jim Vance (OASD-I) and representatives from NSA to discuss planning for briefings to a special group of the Intelligence Subcommittee of the Senate Appropriations Committee. Dr. Hall had previously met with Senator McClellan (Chairman) to establish the general philosophy for this meeting and subsequently with Mr. McConnell (Staff Assistant) to work out the details.

Mr. Colby will meet with the same group on the 25th of April. He has a total of 30-60 minutes and it is understood that he plans first to present essentially the same information provided to the House Armed Services Committee on 1 April to be followed by an internal CIA briefing.

The DoD intelligence briefing is planned for 26 April from 10:00am to 1200 noon. There is a possibility that Senator McClellan may extend for 30 minutes additional time but we should not plan for this. The agenda is as follows:

General description of the over-all Defense Intelligence Program	Dr. Hall	10-15 min.
NRO presentation	Mr. Plummer	40-45 min.
MSA presentation	Director or Vice Director	40-45 min.
DIA presentation	Director	20-25 min.

Dr. Hall will describe the role of the Secretary of Defense as it relates to intelligence (chart attached, Tab A). He will present fiscal trend information of the total intelligence budget (FY75 dollar base). One chart will show inflationary trends using FY75 as the current and the constant year. He will close with a discussion of the basic intelligence policies (Tab B).




Dr. Hall will close by introducing Mr. Plummer as the Under Secretary of the Air Force and the Director of the National Reconnaissance Office to present information pertaining to the National Reconnaissance Program. In turn, Mr. Plummer should introduce NSA and NSA should introduce DIA. It was tentatively agreed at this meeting that the NRO would focus on overhead collection, the NSA on analysis, and the DIA on exploitation.

Arrangements for viewgraphs and briefing stands and security clearance of the room will be made without our involvement. There will be no recording and no transcript of this session.

To assure that there is no undue duplication between speakers and that our presentations flow in an orderly pattern Mr. Vance has scheduled the second meeting early next week at which time outlines of each briefing should be available.
