
**MEMORANDUM FOR THE RECORD**

**SUBJECT: Revised Development Plans for SANDS, MIDAS and RECOVERER**

1. At approximately 1715 hours, 30 November, Dr Charyk called Col Martin to ask about the Air Staff plans for processing the revised Development Plans for SANDS, MIDAS and RECOVERER. He said that he understood that some plan was being made to have Air Staff briefings prior to any discussion with the NSC. He expressed concern that the NSC should have a chance to comment on these plans before they are firm, and noted that the Secretary of the Air Force says that it would be a waste of time to firm up without prior NSC comments and discussion. Dr Charyk stated that this matter had been discussed between Generals Wilson and Schriever and the Secretary at an ANSC-ASC meeting about two or three weeks ago, and that he was surprised to find that any other type of action was being contemplated.
2. Col Martin stated that AFMAG had no knowledge of this requirement for a NSC review and discussion prior to drawing up the revised plans, and that we had prepared a proposed plan that was being staffed and was not yet approved. This plan would have an ANSC-ASC-ASC-ASC briefing team present the revised plans to a joint meeting of the Weapons Board, Space Committee, and Strategic, Reconnaissance and Air Defense Panels on 15 December, with a briefing to the Weapons Board early in January and to the NSC about a week before the 15 January deadline for submission of the plans to the Department of Defense NSC. Col Martin explained that these plans were being revised to include all of the guidance that we have received, and that the time intervals between the briefings were required in order to present a completely staffed plan to the NSC. He noted that there would be about a week for any revisions required by the NSC to be included prior to the 15 January deadline.
3. Dr Charyk stated that the above procedure is inappropriate and should not be followed. He stated that there are some very important considerations that may be left out, that "the Secretary is interested in providing inputs" that will be incorporated into the Development Plans, and that there should be NSC review and discussion prior to firming up any plans so that the plans which are made will have a chance of being bought.
4. Dr Charyk then stated that there is a meeting now scheduled between NSD personnel and Dr Yank in Dr Yank's office on 15 December for the purpose of reviewing the status of the RECOVERER program and the formulation of Development Plans for SANDS and MIDAS. He noted that Dr Kistalowski will attend the meeting. He suggested that arrangements be made for a NSC meeting on either the 14th or 15th of December for a discussion of the Development Plans so that the NSD people could accomplish this task and the 15 December meeting with Dr Yank on the same trip.

5. Col Martin stated that AFMIF had no knowledge of the 15 December meeting and asked if an AFMIF representative could attend. Dr Charyk stated that AFMIF could send a representative to the meeting.

6. Col Martin stated that he would relay Dr. Charyk's instructions to Generals Boushey and Wilson.
