- 1. In a recent meeting with funding data was requested for 7105 and 7106. Because 7106 was under review in the hope of utilizing some recent advances in technology, delays in preparing this submission have resulted. After several meetings with NRO and NSA representatives the concept outlined in reference (a) was adopted and estimates covering the costs were evolved and included.
- 2. Enclosure (1) gives the obligations through 28 February and shows about two-thirds of the total estimate for 7105 obligated. However, some rather large commitments are anticipated in connection with 7105 as shown in enclosure (2). Also, procurements in connection with 7106 will begin immediately on the long time procurement items as shown in enclosure (2).
- 3. Enclosure (3) shows FY 67 estimates for 7105 and 7106.
- 4. In summary the FY 66 obligations plus the estimates for the remaining part of FY 66 for 7105 and 7106 indicate the need for the remainder of the FY 66 money presently held by NRO. It is requested that the remaining \$2 million of FY 66 funds be released by the Comptroller of the NRO sosthat the Naval Research Laboratory can complete the final phases of Mission 7105 and initiate the long lead-time efforts for Mission 7106, on the present schedule. Early release of the FY 67 funds in the amount of \$5.5 million shown in enclosure (3) is also requested.
