TAGBOARD PROGRAM

- 1. The TAGBOARD Program is to be included in the USAE Programming Document with precedence and priority of l-3. The identifier has not yet been assigned but, together with priority, will be authorized for use by specified units when actively supporting TAGBOARD. The priority will be likewise applicable in resolving schedule conflicts where assets in limited quantity may be required simultaneously by competing programs.
- 2. AFSC support will be required in both the test and operational phases.
- a. At this time we anticipate the test phase to continue 12 18 months. JC-130 support now provided from Edwards for parachute recovery tests should conclude by 1 June 1965. The next objective is separation of drone from carrier for which JC-130, PMR, and AFWTR support will be required. These tasks have been identified in detail by PMR directive. After initial separation, one flight per month is planned until tests are concluded. Two weeks' notification of separation dates will be provided all units participating.
- b. The operational phase will require support from the 6594th Recovery Group only. Assuming an expenditure of ten drones during test, an additional ten will be available for actual operations. (There is some possibility of a follow-on buy of 15 drones). We contemplate a consumption no greater than two drones/month dependent upon target priority and weather conditions. At this time, all recovery operations are planned from Incirlik or Kadena (not simultaneously).
- 3. Since it would seem somewhat revealing for the 6594th, with its known mission, to suddenly begin deployment to either of the above bases, propose that cover flights be scheduled beginning FY 66. Prior to such deployment, coordination with the respective commands will be effected by this office. You will be further advised as to the date for actual initiation of this requirement; frequency should be approximately once per two months to either location on a random basis.
