THIS PROGRAM IS TO BE BASED ON THE COMPLETION OF PROCUREMENT OF 15 SYSTEMS FOR FY 1965, WITH A PLANNED LAUNCH SCHEDULE OF 2 IN JULY AND 1 PER MONTH THEREAFTER. PROVISION IS TO BE MADE WITHIN THE PRESENT ASSET AND PROCUREMENT QUANTITIES FOR 6 M or J STANDBY SYSTEMS BY NOV 64; IT IS UNDERSTOOD THAT 6 SYSTEMS ARE NOW AVAILABLE AND THAT SCHEDULED DELIVERIES LESS SCHEDULED LAUNCHES BETWEEN NOW AND NOV WILL ALLOW THE MAINTAINING OF THE 6 STANDBY CAPABILITY AT THAT POINT AND THEREAFTER.
