The previous status update to ISOO on the progress on the FCGR from October 2016, along with the current status update from February 2017 are attached. In Section C: Security Classification Guides (SCG), the status update count varies within the reporting from 53 in October 2016 to reporting 48 in February 2017; this is due to the Integrated National Reconnaissance Office Classification Guide being inadvertently counted as standalone guides, in October.
