29 DECEMBER 1961. UNGA RESOLUTION CALLING UPON THE MEMBER STATES TO REGISTER SPACE LAUNCHINGS AT THE UN. THIS CAME ABOUT AS A RESULT OF A SPEECH BY THE U.S. AMBASSADOR TO THE UN.

JANUARY 1962. MUCH DISCUSSION BETWEEN STATE, CIA, DEFENSE, DFRD CONCERNING WHETHER NRO LAUNCHES SHOULD BE REGISTERED AND IF SO, WHAT INFORMATION SHOULD BE

22 JANUARY 1962. GEN TAYLOR AT THE WHITE HOUSE APPROVED THE STATE PROPOSED FORMAT AND PROCEDURE FOR UN REGISTRATION. THE ITEMS IDENTIFIED FOR RELEASE INCLUDED: (1) INTERNATIONAL DESIGNATION OF OBJECT, (2) LAUNCH VEHICLE, (3) PURPOSE OF THE SATELLITE OF (A) DEVELOPMENT OF SPACE FLIGHT TECHNIQUES, (B) SPACE RESEARCH AND EXPLOATION, (C) DEVELOPMENT OF PRACTICAL APPLICATION OF SPACE-BASED TECHNOLOGY, (D) NON-FUNCTIONAL OBJECT, (4) DATE OF LAUNCH, (5) BASIC ORBITAL PARAMETERS, INCLUDING NODAL PERIOD, INCLINATION, APOGEE AND PERIGEE.

5 MARCH 1962. U.S. SUBMITTED FIRST SPACE OBJECT REGISTRATION LIST TO UN SHOWING ALL OBJECTS IN ORBIT AS OF 15 FEB 62.

12 APRIL 1962. THE SPECIAL GROUP ADDRESSED THE UN REGISTRY QUESTION DIRECTED THAT NO CHANGE IN THE PRESENT U.S. PRACTICE OF REGISTERING THOSE SATELLITES
