SUBJECT: DNRO's Recommended Program Schedule

In accordance with our discussions concerning the Pre-CFI briefing, I have reviewed the schedule for preparation and dissemination of the DNRO's Recommended Program. Based upon the potential for three days of discussion, 19-21 October, we now plan to deliver the Recommended Program to the printer on 26 October and have it available for distribution by COB 27 October. In the event that the discussions do not require the full three days, we will attempt to deliver the Recommended Program earlier.

I realize that this new schedule will allow essentially no time for review of the Recommended Program prior to the currently scheduled CFI review. I recommend that consideration be given to rescheduling the CFI review of the NRP no earlier than Monday, 1 November 1976. This would allow the principals and their staffs at least two days plus a weekend for review prior to the meeting.
